EDENRED COMBINED GENERAL MEETING OF MAY 11, 2022

Practical details to **participate remotely** in the Q&A session during the Meeting

Edenred's shareholders who do not physically attend the 2022 General Meeting are invited to participate remotely in the Q&A session that will take place during the Meeting. To this end, Edenred has chosen to use the "AG à distance" (remote GM) tool from the service provider DMI/MMA.

The interested shareholder must use the link agd.dmint.net/edenred¹ to identify and register on the day of the General Meeting (May 11, 2022) from 8 a.m. (Paris time) and until to the Q&A session during the Meeting.

The shareholder will have the opportunity to ask questions via text, audio or video and to check his/her audio or video recording before validating it and submitting it.

The Company will do its best to answer as many questions as possible, according to their order of arrival and, if necessary, by grouping them together by topic according to their number, as well as taking into account questions asked by shareholders attending the General Meeting in person, within the time allotted for the Q&A session.

Online identification is secure, and the shareholder will have 3 options to do so:

- ▶ **if the shareholder has participated via VOTACCESS in Edenred's 2022 General Meeting:** by entering the last digits of the requested VOTACCESS reference code; **or**
- ▶ **if the shareholder has already registered on the "DMI/MMA's remote GM" tool at a previous General Meeting (including outside Edenred):** by entering his/her e-mail address and password; **or**
- ▶ **if the shareholder finds himself/herself in another situation:** by entering his/her personal data (title, first name, last name and address).

FOR THE SHAREHOLDER WHO PARTICIPATED VIA VOTACCESS TO EDENRED'S 2022 GENERAL MEETING

The shareholder must **enter the requested code**.

He/she will then directly be on the acceptance of the terms and conditions of use page. If the shareholder accepts them, he/she will have access to a personalized web page to watch Edenred's 2022 General Meeting live and ask questions via a text, video or audio message².

FOR THE SHAREHOLDER WHO ALREADY REGISTERED ON THE « DMI/MMA'S REMOTE GM » TOOL AT A PREVIOUS GENERAL MEETING (INCLUDING OUTSIDE EDENRED)

The shareholder must **enter his/her e-mail address and password**:

- ▶ **for a registered shareholder:** he/she will then directly be on the acceptance of the terms and conditions of use page³. If the shareholder accepts them, he/she will have access to a personalized web page to watch Edenred's 2022 General Meeting live and ask questions via text, video or audio message²;
- ▶ **for a bearer shareholder:** he/she will then be invited to download, or capture via the camera of his/her device, the following documents: **(i)** a certificate of share registration and, where applicable, **(ii)** a register extract (only if he/she is a representative of a legal person) and/or **(iii)** a signed proxy (only if he/she acts as proxy of another shareholder):
 - an online MMA operator will then check the validity of the document(s) provided;
 - if the MMA operator confirms the validity of the document(s), the "DMI/MMA's remote GM" tool will then send an invitation e-mail containing a secure and personalized link to this shareholder;
 - the shareholder will then be guided to the personalized web page to watch Edenred's 2022 General Meeting live and ask questions via a text, video or audio message².

FOR THE SHAREHOLDER WHO FINDS HIMSELF/HERSELF IN ANOTHER SITUATION

The shareholder must **enter the following personal information (i) civility, (ii) first name, (iii) name and (iv) address**:

- ▶ **for a registered shareholder:**
 - he/she will be invited to enter his/her e-mail address and take a photo ("selfie") with his/her identity document by activating the camera of his/her device (valid documents: national identity card, driver's license, passport)⁴;

- if this correlation is proven, the MMA operator will activate the sending of an invitation e-mail containing a secure and personalized link to the shareholder's e-mail address;
- the shareholder will then be guided to the personalized web page to watch Edenred's 2022 General Meeting live and ask questions via a text, video or audio message⁵.

▶ **for a bearer shareholder :**

- he/she will be invited to enter his/her e-mail address and take a photo ("selfie") with his/her identity document by activating the camera of his/her device (valid documents: national identity card, driver's license, passport);
- he/she will then be invited to download, or capture via the camera of his/her device, the following documents: **(i)** a certificate of share registration and, where applicable, **(ii)** a register extract (only if he/she is a representative of a legal person) and/or **(iii)** a signed proxy (only if he/she acts as proxy of another shareholder);
- an online MMA operator will check the correlation of the document with the shareholder's photo and with the name as well as the validity of the document(s) provided;
- if this validity is proven, the MMA operator will activate the sending of an invitation e-mail containing a secure and personalized link to the shareholder's e-mail address;
- the shareholder will then be guided to the personalized web page to watch Edenred's 2022 General Meeting live and ask questions via a text, video or audio message⁵.
